Conditions of entry

1. Contestants must be currently working full time in the fruit and vegetable industry in an organisation that is closely associated with growing.
 2. Contestants must be 30 years of age or under as at 31 December 2022.
 3. Contestants must show evidence of completing a minimum of three years practical work experience in the fruit and vegetable industry with the regional coordinators ensuring the 3 years practical experience is met. E.g. letter from employer.
 4. To enter the competition the application form must be completed and emailed to the contact person on or before the close off date.
 5. Contestants must be available, if selected, to compete in the Young Grower of the Year competition in Nelson 21-22 September 2022. (All travel costs will be met by Horticulture New Zealand).
 6. The contestant agrees that if they win Young Grower of the Year they must be available to compete in the AGMARDT Market Innovation Project (date to be confirmed) and the Young Horticulturist of the Year competition (to be confirmed).
 7. Contestants agree to abide by the competition rules.
 8. All entrants must be familiar with health and safety issues associated with competition activities and follow the procedures set in place on the day.
 9. Contestants must be fully vaccinated and supply a vaccine pass and photo ID with their entry form.
 10. Must be a New Zealand citizen or hold a current New Zealand residency permit.
 11. The winners of the competitions will be expected to be available for promotional purposes and give interviews as required to the media at and following the event.
 12. The contestant will be available to promote the competition where applicable.
- CONTESTANTS MAY REAPPLY TO REGIONAL COMPETITIONS EVEN IF THEY HAVE WON YOUNG FRUIT GROWER OR YOUNG VEGETABLE GROWER. HOWEVER THE WINNER OF THE YOUNG GROWER OF THE YEAR CANNOT REAPPLY AT A REGIONAL OR NATIONAL LEVEL.
