



# Commodity Levy Requirements for Vegetable Growers

All vegetable growers are required to pay a levy if they sell produce in a commercial capacity (levy orders are a legal requirement). This will include cash sales from road side stalls and farmers markets.

### There are 3 levies to pay for all vegetable growers:

1. Commodity Levy to the Product Group – e.g., onion grower pay levy to Onions NZ.
2. Commodity Levy to Horticulture New Zealand – all vegetable growers.
3. Biosecurity Levy to the Product Group – e.g., tomato grower pay biosecurity levy to TomatoesNZ (NB: a biosecurity levy has not been enacted by all product groups)

Please note, levy rates are fixed before the start of the levy year by a vote at each product groups annual general meeting (AGM).

## Worked Example

A grower growing potatoes, carrots and onions is required to pay levies to Horticulture NZ, Potatoes NZ, Vegetables NZ and Onions NZ separately. See below.

### GROWER LEVY CONTRIBUTION PER CROP

Onions NZ			$\$2.50 \times 70 = \mathbf{\$175}$
Horticulture NZ	$(35,000/100) \times 0.14 = \mathbf{\$49}$	$(\$20,000/100) \times 0.14 = \mathbf{\$28}$	$(35,000/100) \times 0.14 = \mathbf{\$49}$
